


Tom Glow is the Paving Manager for the City of Omaha Public Works Department Construction Division and is responsible for the oversight of most major roadway improvement projects involving City resources. As the Project Manager for the 144th Street Project, Tom oversees all phases of the construction including project management, contract administration, utility relocations, public information services, inspection, and construction staking. Jeff Sockel is a Project Manager responsible for the oversight of construction services as well as providing design assistance on HWS projects. He assisted in the design and utility coordination for the project and is HWS' Project Manager for testing and construction consultation services.

The project includes roadway improvements to 144th Street and the realignment of State Highway 50. Roads are being upgraded from a two-lane rural section to a four-lane divided

## Call for Nominations – 2006 Excellence in Journalism Award

The ASCE Excellence in Journalism Award was established in 1994 by Past President James Poirot to foster better relationships between ASCE Sections and Branches and the news media. The award honors journalists for enhancing public understanding of the role and impact of civil engineers and the civil engineering profession through their outstanding news coverage.

Starting this year, eligibility for the Award has been expanded to include journalists and producers from national newspapers, radio and television stations, magazines, and electronic and Web-based news outlets, in additional to the local and regional newspapers formerly eligible. ASCE strives to encourage and expand news coverage of civil engineering and related issues through the Journalism Award, as a means of engaging the public and promoting the profession.

We encourage you to monitor your local news and nominate a story, or stories, in any of the five categories. Entries must be postmarked by June 1, 2006. urban section with curbs and storm sewer. The project is 1.6 miles long including new pavement, storm sewer, traffic signals, noise walls, sidewalks and a bike path. The project abuts newly developed areas, existing residential neighborhoods, commercial centers, and an elementary school.

The first segment of the project ("L" St. to Dayton St. along 144th St.) was recently completed this last fall. The second of the project ("L" St. to "Q" St.) is currently underway. The final segment of the project (Madison St. to "Q" St.) will begin construction in 2007.

What is unique about this project? This project involves Omaha's *first triple left turn lanes* at 144<sup>th</sup> and Millard Avenue. This project is also the first to implement the recommendations of the *Mayor's Road Construction Task Force* to reduce construction time. Contractor *incentives and disincentives* have been incorporated in this project.
